Dr. Potdar, Secretary of CSSC, felicited a few Sr. citizens by cutting the cake in order to celebrate IDOP 2020.







First webinar on 9th December, 2020.


Topic - Healthy Ageing: Body & Mind

Dr. Kazi promised in the Webinar to the Chief Functionary, Mrs. Nirmala Samant Prabhavalkar that Anjuman-I-Islam is ever ready and all cooperating to shoulder of establishing Day Care Centres or Home for The Aged which would not only be an extended arm of the Government but a way of paying back to the senior citizens what they have been rightfully deserving. Dr. Kazi expressed his willingness for establishing Non-Government Research and Development Cell as a Pilot Project for monitoring the wellbeing of the Senior Citizens.

First Speaker: Mr. Yatin B. Game Sir mentioned need for Day care centres for Senior citizens and its provision in this Act. He gave insights on how this act provides in-expensive and speedy procedure to claim monthly maintenance for parents and senior citizens obligating children/relatives to maintain their parents/grandparents and senior citizens respectively. He bought attention that this act provides setting up of old age homes for providing maintenance to the indigent senior citizens and parents.

Second Speaker: Mr. Behzad Irani, highlighted the amendments and key changes that this legislation brought in the form of a separate tribunal for the redressal of grievances prior to which the aggrieved would file a claim for maintenance under <u>Section 125 of the Code of Criminal Procedure, 1973</u> resulting into the aged person approaching the court for relief and incurring heavy expenses to file and litigate the suit. The process was <u>simplified</u> under the MWPSC Act 2007.


Fourth Webinar on 21st December, 2020 Topic: Nutrition Care of Senior Citizen


Topic : Aging & Assisted Home Care

She told about the National Programme for the Health Care of the Elderly (NPHCE), released in early 2011, Social security provisions for pension, income tax benefits, provident fund gratuity, and medical assistance have been strengthened.

Adv. Hegde spoke about the legal issues that are commonly faced by the senior citizens community. He emphasised that our seniors are our responsibility. Intergenerational equity is a principle of natural justice. His focused on, urgent need to amend the Constitution for the special provision to protection of aged person and bring it in the periphery of fundamental right. With the degeneration of joint family system, dislocation of familiar bonds and loss of respect for the aged person, the family in modern times should not be thought to be a secure place for them. Thus, it should be the Constitutional duty of the State to make an Act for the welfare and extra protection of the senior citizen including palliative care.

Second Speaker: Dr. Vijay Ryhakar, Resident Manager, Athashree Aastha, Pune




On 10th March, 2021 - CSSC organized the centenary celebration of our Founder late Smt. Indumati Parekh born on 8th March.







Topic – COVID vaccine & Frequently asked questions.

She started with PPT, her session was very informative. Some of Frequently asked questions: I just had covid infection- should I take vaccination ?

- ▶ Persons having active symptoms COVID infection.
- ► COVID patients who have been given monoclonal antibodies or convalescent plasma
- Acutely unwell and hospitalized (with or without intensive care) patients due to any illness

► COVID vaccination is to be deferred for 4-8 weeks after recovery

Pregnancy:

- Currently limited data on the safety of COVID-19 vaccines in pregnant ladies because these vaccines have not been widely studied in pregnant individual
- Therefore, women who are pregnant or not sure of their pregnancy; and lactating women should not receive COVID-19 vaccine at this time

Expected side effects:

- ▶ Pain where the shot is given,
- Fever,
- Chills,
- Tiredness,
- ► Headache for 1-2 days

If you develop fever

- ✓ Take Crocin
- ✓ Rest
- \checkmark If symptoms do not disappear after 2-3 days then contact the vaccinator.

Can I take One dose of Covishield one dose of Covaxin ?


- The vaccines available are not interchangeable, it is important to receive the second dose of same vaccine as the first one.
- The COWIN app is also going to help to ensure that everyone receives the same vaccine.



Third Speaker: Dr. Rajendra Borkar, State Immunization Officer, Diretorate of Health Services, Panaji Goa. Topic: What is Covid Second Wave?

India's surge in infections began around mid-March and increased rapidly, He said it is because of people behaviour about the corona. Human behaviour is the major factor. State and local governments, as well as individual people, differ in their response to the pandemic. Some follow COVID-19 precautions, such as **physical distancing**, **hand-washing and mask-wearing**. Others are not as prescriptive in requiring these measures or in restricting certain high risk activities.

In some cities, towns and communities, public places are closed or practicing limitations (such as how many people are allowed inside at one time); others are operating normally. Some government and community leaders encourage or even mandate mask wearing and physical distancing in public areas. Others say it is a matter of personal choice.

However, the relationship between those precautions and cases of COVID-19 is clear: In areas where fewer people are wearing masks and more are gathering indoors to eat, drink, observe religious practices, celebrate and socialize, even with family, cases are on the rise.

Also, places where people live or work closely together (multigenerational households, long term care facilities, prisons and some types of businesses) have also tended to see more spread of the coronavirus. Coronavirus outbreaks at nursing homes and "superspreader" events gatherings of people where one infected person or more transmits the virus to many others continue to occur and this will lead to second wave of corona virus.

Topic: Covid & Elderly

The pandemic has brought in tough times for senior citizens at old age home said Prakash Borgaonkar, he said earlier, there used to be various sessions, festival celebrations, visits, but all have stopped completely. They are not even allowed to touch their family members in care of a visit. Many of the inmates at old age home are not even vaccinated. Help Age India looked after the vaccinations of Senior citizens.
